- 5 Update regulations based on section 54 of the Modern Slavery Act, Labor Law(s) of PRC.

Those companies who are involved in slavery and human trafficking will not be considered in our supplier chain.

Chinatungsten Online (Xiamen) Manu. & Sales Corp. expects its employees to adhere to its company regulations and business ethics which have been documented in our systems. The code of ethics is available and communicated to all our employees within our group both by notice and training, and confirmed by the attendees.

In order to support the anti-slavery and human trafficking, Chinatungsten Online (Xiamen)Manu. &Sales Corp. has provided hot/special line and established Labor Union to supervise and implement laws and regulations regarding to staff activities regularly, set up special computer system for collecting suggestions, opinions complains from all employee, and deal with the issues that staff reflect. Websites, social media accounts and any other notice board are main methods to disclosure the illegal and immoral behaviors.
